INTRODUCTION

Since the first performances of wind bands in the United States around 1792, the musical function of Concert Bands has drastically changed. Due to the development of instrumental music programs in secondary schools and the growing repertory of serious wind literature, we now have the opportunity to expand our own individual talents and group performance levels higher than ever before. With this in mind, it is essential that we stress **MUSICAL GROWTH** as the first and primary goal in our approach to the Wind Symphony at Mason High School.

Daily instruction will involve musical fundamentals, sight-reading, chamber music, solo and ensemble music, and preparation of Concert Band literature. All band members will need to prepare accordingly for the demands set before them. **INDIVIDUAL PRACTICE TIME** will become necessary in order to accomplish successful rehearsals **TOGETHER!**

The individual and group achievements this year will be directly related to the quality of daily preparation; **PRACTICE** your part, **WORK TOGETHER**, and constantly **SET HIGHER GOALS!**

PHILOSOPHY OF MUSIC EDUCATION

Music is a fundamental piece of the human experience. This makes music education a necessary endeavor to ensure that the whole child is being educated. To this end, it is the philosophy of the Mason High School Band Program to educate, to the fullest extent, every child enrolled in band. This shall include skill development, cognitive understanding, and aesthetic appreciation for many forms of music from many cultures.

The primary objective of the Mason High School Band Program is to develop the performance, rehearsal, and personal practice skills of each student. Students are expected to have a good work ethic, show consistent progress, and develop goal-setting skills.

Public performance is viewed as a useful tool to help students achieve success in band. Mason High School band students are provided concert band performance opportunities plus experience in small ensembles and solos.

CLASSROOM PROCEDURES

- 1) Report to class promptly and prepare for rehearsal. To receive full classroom performance credit, students must have their instrument, proper accessory equipment (such as two working reeds, valve oil, stick bag with mallets and/or sticks), pencil, music, tuner, and anything else deemed essential by the directors.
- 2) Warm-up intelligently, moderate dynamic levels with maturity. Respect the rights and needs of the other band members.
- 3) Four minutes after the tardy bell rings, you should be in your seat, with all music and equipment ready to rehearse.
- 4) All members must be in the performance facility by tardy bell.
- 5) When the conductor steps onto the podium, everyone should cease what they are doing, be quiet, and listen to the directions for the start of the rehearsal. All announcements will be given at the beginning of each class.
- 6) Individual conversations and interruptions during rehearsals are not conducive to our primary goal of **MUSICAL GROWTH**. If you have a question or would like to say something, please raise your hand and you will have the opportunity to express yourself.
- 7) Take time after rehearsals to give your instrument and the music proper care. Neatness and cleanliness are essential in our organization. Please take pride in your facility and make sure everything is in its proper place.

CLASSROOM BEHAVIOR RULES

- 1) Be on time to class.
- 2) Sit in your assigned seat.
- 3) No gum or food permitted in the performance facilities any time.
- 4) No classroom disruptions during rehearsal time.
- 5) Take care of classroom materials and our facilities.
- 6) Students must have instrument, proper accessory equipment, pencil, and music for every day of rehearsal.

BREAKING OF THE RULES

- 1st offense: Verbal warning and/or conference with the student.
- 2nd offense: Detention with student and student/teacher conference. (All detentions are for ½ hour. Students and parents will be notified 24 hrs. in advance.)
- 3rd offense: Detention with personal parent contact.
- 4th offense: Parent/teacher conference and disciplinary action as discussed with student and parent. An administrator may be involved in this conference.
- 5th offense: School discipline administrator involved.

SEVERE CLAUSE – A STUDENT MAY BE SENT TO THE OFFICE IF THE DIRECTOR FEELS IT IS NECESSARY.

FOLLOWING THE RULES

- 1) Enjoyable and fun rehearsal.
- 2) Praise.
- 3) Rewarding concerts and contests.
- 4) An assertive, responsible, and disciplined group.
- 5) Rewarding outside musical experiences.

GRADING

With **MUSICAL GROWTH** as our primary goal, five areas of importance surface when evaluating individual band members.

- 1) **CLASSROOM PERFORMANCE** - musical performance in class, promptness, daily preparation, respect for facility, attitude and discipline (25% of total grade).
- 2) **CONCERT PERFORMANCE** – attendance at and performance in all required concerts and rehearsals (30% of total grade).
 - Concert Performances (including chamber events)
 - Solo & Ensemble Adjudicated Event (all students must take a solo)
 - O.M.E.A. District and State Performances
 - Concert Band Camp
 - Pep Band Performances
 - Memorial Day Parade (marching band members only)
 - Community Performances
 - Sectional and Dress Rehearsals
- 3) **PERFORMANCE TESTING** – (35% of total grade)
 - Scale Jury-major scales up to seven flats and seven sharps, quarter note equals 120 beats per minute using rhythm pattern(s) including arpeggios
 - Scale Jury-minor scales up to seven flats and seven sharps, quarter note equals 120 beats per minute using rhythm pattern(s)
 - Honor Band Music
 - Private Lesson Journal
 - Testing of wind music-fundamentals of music (written and aural)
- 4) **SEMESTER EXAM** - Playing/Written Final (10% of total grade)
- 5) **HONORS CRITERIA** -
 - 1) Prepare and perform an O.M.E.A. class A, B, or C small ensemble piece and an O.M.E.A. class A, B, or C solo to the standard of O.M.E.A. criteria of tone quality, intonation, technique, dynamics, phrasing, interpretation, and overall impression. (Juniors)
 - 2) Prepare and perform an O.M.E.A. class A or B, small ensemble piece and an O.M.E.A. class A or B, solo to the standard of O.M.E.A. criteria of tone quality, intonation, technique, dynamics, phrasing, interpretation, and overall impression. (Seniors)
 - 3) Write and play all major and minor scales, quarter note equals 120 beats per minute using rhythm pattern(s) established by the band directors.
 - 4) Prepare music for District XIII Honor Band Auditions.
 - 5) Create a written document or presentation, (i.e.: Power Point, or dramatization) addressing one or more of the following: (Seniors only)
 - a) musical period, b) composer c) musical style, d) musical form, e) major work,
 - f) analyzation of a musical composition.
 - 6) Attendance and critique of one collegiate or professional performance per trimester (Concert Critique). Students must identify theme, programming, musical elements, and presentation. (Juniors and Seniors)
 - 7) Ten hours of community music service/experience. (Seniors)

** 65% of your total grade will be a combination of performance opportunities and by how well you play your Concert, Solo and Ensemble, and contest literature. PLEASE NOTE: You must receive a grade of a “B” or better on all of your music. In addition, if a performance or rehearsal is missed without director approval, your grade will be affected based on the percentage designated. In rare occasions, a written musical assignment might be assigned to replace a performance or rehearsal that was missed.

CONCERT ATTENDANCE

Concert attendance is mandatory. All members are expected to play in all scheduled performances dressed in proper concert attire (see Concert Attire). Students are to arrive at the performance venue at least forty-five minutes before the concert starts to tune and warm up.

Performance attendance is equal to 30% of a student’s grade in band. An unexcused absence from a performance will result in a failing grade for that portion of their average. Absences are unexcused except in emergency cases or personal illness. Any school activity conflict must be worked out between the advisors (including the band director), student and parents at least three weeks in advance. The student has the responsibility to inform the band director immediately when the conflict is discovered.

In the event of an excused absence, the student may receive the full 30% performance grade credit by bringing in a letter (in emergency/illness cases) upon their return to school, signed by the student’s parents explaining the reason for their absence. The director may call for further verification. In addition, students with excused absences must attend a professional or collegiate concert and write a 2-3 page paper on their observations to receive full credit. Just as a student who is sick the day of a major test is allowed to make up the test, so is a student who is absent the day of a performance. For unexcused absences no make up opportunity is given.

CONCERT CRITIQUE

The purpose of the Concert Critique is to communicate the student’s feelings and impressions about musical performances, to become a musically literate person, to listen critically, and to help develop attitudes, feelings, and make intelligent decisions concerning different types of musical performances. The Band Member will be required to attend and write a critique on their impressions of a live musical performance, collegiate or professional, not connected with the Mason Music Department.

TRIMESTER TESTING DATES

- A. FIRST TRIMESTER PERIOD August 22 – November 16
Playing and written evaluations will be done throughout the 1st trimester.
- B. SECOND TRIMESTER PERIOD November 18 – March 1
Playing and written evaluations will be done throughout the 2nd trimester.
- C. THIRD TRIMESTER PERIOD March 5 – June 5
Playing and written evaluations will be done throughout the 3rd trimester.

SEATING AND CHALLENGES

Through the scheduled music testing sessions in class, any student may move up or down within each section according to how well they perform their music. All testing will be done by the directors with results posted the day after the students play. Should anyone wish to schedule a music challenge, he/she should contact the director and schedule a time during trimester testing weeks. PLEASE NOTE: Students who opt to challenge in this manner must have a current grade of “B” or better in order to qualify. Challenges will involve sight-reading and/or Wind Symphony literature.

SECTIONAL REHEARSALS

Starting in August, students will be required to attend sectional rehearsals. Each sectional will last approximately one hour and a half. Sectionals will deal with the very fine details of music (musicality, range, intonation, specifics on various instruments, and limiting during various music passages). **ALL SECTIONALS ARE MANDATORY.**

FINANCIAL INFORMATION

It is the policy of the Mason Music Department to provide this information regarding the finances of the performing organization. If there is a problem in meeting any of the commitments explained in this section, please feel free to contact Mr. Robert Bass at 398-2798 ext. 30271.

This section of the handbook explains the expenses of being in Instrumental Music during 1st, 2nd, and 3rd trimesters. Expenses include such things school band fees, which includes clinicians, award ceremonies, supplies, as well as contest fees. In addition there are costuming fees i.e. tux rental, dress purchase etc. It is necessary for each student to realize these expenses and be willing to help support their band and the entire instrumental program.

The Mason Booster Organization is a parent booster organization that assists each of the music students in meeting their financial obligations and therefore their success as a student in the Mason Music Program. The purpose of the Booster Organization is to take charge of fund-raisers so that additional finances can be raised to pay for needed items. Those additional monies pay for social events and awards for the students.

SCHOOL FEES

Wind Symphony fees are charged with all other school fees and paid to Mason City Schools.

The members of Wind Symphony help support the band budget for the 2011-2012 school year. Each student is responsible to pay \$45.00 school band fees plus gentleman also pay a \$35 tux rental fee to Mason City School. The band fee covers a portion of solo and ensemble, method book, and Concert Band Camp costs.

Ladies - \$45

Gentlemen - \$45 + \$35 tux rental = \$80

APPAREL PURCHASES

All apparel is purchased through the Mason Band Boosters.

Ladies will purchase a black dress for \$65.00 and pearls for \$10 from the boosters.

Gentlemen will purchase a tux shirt for \$15 from the boosters.

(If you already have a tux shirt or dress/pearls from being in one of the other Mason ensembles from last year you do not need to repurchase them. These items are the same style.) The boosters will notify each class when they will be fitted for their apparel. Payment must be received by the boosters before apparel is distributed.

Private Lessons 2011-2012

Half hour private lessons are offered to band students in the Mason City Schools. Lessons are taught by an outstanding staff of professional performer/teachers and are scheduled Monday through Friday after school and evenings at either Mason High School, Mason Middle School, or at the instructors' private studio.

The band directors in the Mason City Schools agree private lessons are the most effective way for young musicians to fully develop their performing talents. Private teachers help students develop tone quality, technique, musical style, practice discipline and preparation for solos, playing tests and auditions. The lessons use a combination of explanation and demonstrations while building the student's confidence to enjoy playing in group or solo situations. Private teachers use a variety of materials including solos, exercise books, audition materials, as well as parts from full band arrangements.

Private lessons are also beneficial for students attempting to learn a second instrument. In the Mason Middle and High School bands many of our players have worked to achieve this goal, resulting in opportunities to perform in many types of concert, marching and jazz ensembles plus helping to improve the instrument balance throughout our schools' band program. In addition, students who have fallen behind the performing level of their band and need extra help to catch up find the one-on-one attention of private lessons especially helpful.

The cost of private instruction ranges from \$15.00 to \$25.00 per thirty-minute lesson with payments usually made four lessons in advance. Lessons can be started or stopped any time during the school year with makeup lessons given for illness, emergencies, or other excused absences. Lessons are not given during holidays or on days when school is not in session. During the winter lessons are cancelled if school is closed or dismissed early. A few of our teachers continue their lessons in the summer but for the most part private lessons are taught from October through May.

Band students at Mason High School who do want lessons should fill out the bottom of this page and turn it in to the directors at school. A private teacher will call at home to explain more about their lessons and to arrange a day and time.
